## **Engagement Rules and Conditions**

**Event Times:** Friday, July 13 from 6:00 pm to 12:00 am

Saturday, July 14 from Noon to 12:00 am

**Setup Times:** Beginning at 12:00 p.m. Friday, July 13

Beginning at 9:00 a.m. Saturday, July 14

**Utilities:** Power is available for an additional charge, and must be requested in

advance. Vendor must provide extension cords to connect to power source.

Water and drain/sewage facilities are not provided.

## General:

- Vendor goods and services will NOT be duplicated. All registrations will be handled on a first come, first serve basis.
- Vendors are expected to be open and staffed during scheduled event times. Event is Rain or Shine.
- Vendors are solely responsible for their own setup and cleanup, including waste disposal (there will be waste receptacles on site)
- Vendors are responsible for providing their own equipment and supplies, including but not limited to extension cords, lights, tables, chairs, tents, etc.
- Vendors will be assigned a location at the event site. Vendor's setup may not interfere with adjacent vendors.
- NO alcoholic beverages are permitted to be sold.
- **FOOD VENDORS**: Every attempt will be made to NOT duplicate food offerings by vendors, however, some items may be available at more than one vendor booth...beverages, fries, etc.
- Food vendors are responsible to abide by the rules and regulations established by the Pennsylvania Board of Health, and must have at least one person who is ServSafe Certified.
